Vice President's Message

Well it has been a few months now that I have been back on the tools and an active member of the EVO Plant Maintenance department. As the shift Millwright on A-Crew I was quickly shown the difference between how EVO operates in comparison to CMO. Obviously we pump out a lot more coal in a shift and take significantly less down time in an effort to try and reach the 9 million ton production target the mine has set. This has been a serious struggle for the plant since the big tie in this winter. The new equipment has changed the way we are able to process coal and has now presented many new

challenges which will need to be addressed over the coming months. Initially this led to a lot of random down time as operations and maintenance chased plugging and mechanical issues all over the plant. Slowly the group was able to work through the issues and get the plant running in a satisfactory way. We learned quickly that the ability to feed the plant was going to be a challenge and that our disc filters were going to need some much needed updates and repairs. All in all things seem to be moving in the right direction and we will slowly reach our targets. Of course dealing with COVID-19 while trying to get all this work done has added to the challenge. I honestly think the mine has done a pretty good job of dealing with concerns and doing what can be done to ensure our safety at the work place. Unfortunately it is our own members that have been struggling to follow the rules around social distancing and face coverings. Don't get me wrong, I'm over it too. However with these rules and regulations seeming to be sticking around for the foreseeable future we must keep doing what we can to keep each other safe. Many of us have children back in school now and we all know that this will undoubtedly present its own challenges.
